Budget Advocacy Alert: Your Advocacy is Needed Now!

The Fiscal Year 2019 budget process is underway and the budget is now before the Senate Ways and Means Committee. We need your help to reach out to your State Senator ASAP and ask them to make the following budget requests a top priority. The Senate is busy finalizing their budget request right now so time is of the essence.

Early Intervention: The House Ways and Means Committee supported the Consortium and Governor Baker's requested budget funding of \$29.3 million for **EI services**. Now we are asking the Senate to support the \$29.3 million funding request in their budget to preserve EI services.

Taunton Area School to Career: Mentoring Matching Grants line item 7061-9634, assists in funding TASC's Career Mentoring program. The House approved the requested amount of \$750,000, which we are asking the Senate to support. **School to Career Connecting Activities** line item 7027-0019, assists in funding all of TASC's career education activities. The House approved \$3,918,499, which we are asking the Senate to support, as well. Please help us to **"Empower Youth to Succeed"**.

Wise Adult Day Health: Programs have been advocating for a fair rate adjustment of an \$8,000,000 increase. The House version of the budget included a 2,000,000 increase. While this is significant, it is insufficient to meet the needs of medically frail adults and seniors! Please ask your Senator to support an \$8,000,000 increase.
